

## Lystra Automart Vehicle Sales on Behalf Terms and Conditions

### 1. Sales on Behalf Agreement

- Lystra Automart acts as a trusted intermediary to sell vehicles on behalf of our clients.
- The client authorizes Lystra Automart to market, negotiate, and sell their vehicle under the terms outlined in this agreement.

### 2. Service Fee

- Lystra Automart charges a commission of **5% of the final sale price** of the vehicle.
- The service fee is deducted from the sale proceeds before the balance is transferred to the client.

- Either party may terminate this agreement with **7 days written notice**, provided the vehicle has not yet been sold.

- Any disputes arising from this agreement will be resolved amicably. If unresolved, disputes will be governed under Kenyan law.
